JOB SUMMARY:

Performs routine public safety work in the enforcement of city ordinances, parking enforcement ordinances, code enforcement ordinances, and abandon or discarded vehicle ordinances.

ESSENTIAL JOB FUNCTIONS:

- Does routine patrol of City streets for illegally parked vehicles and civil code violations such as illegal signs, garbage and debris, weeds and tall grass, City park ordinances, abandoned or discarded vehicles, and works to rectify any violation located within the City.
- Investigates Municipal Code complaints. Follows municipal civil infraction code procedures to compel resolution of complaints.
- Maintains accurate and up-to-date notebook and complaint logs.
- Prepares reports on enforcement activities and citizen contact.
- Maintains up-to-date knowledge of applicable codes, regulations, and Ordinances.
- Works an assigned shift using good judgment in deciding course of action being expected to handle difficult situations.
- Carries out duties in conformance with Federal, State, County, and City laws/ordinances and policies.
- Handles other tasks as assigned.

QUALIFICATIONS:

Minimum Education and Experience:

- a. High school diploma or GED equivalent
- b. An equivalent combination of education and experience.

Desirable Experience:

a. Background and experience in law enforcement

Necessary Knowledge, Skills and Abilities:

- a. Some knowledge of law enforcement principles, procedures, techniques, and equipment.

- c. Ability to learn the applicable laws and ordinances.
- d. Ability to communicate effectively orally and in writing.
- e. Ability to establish and maintain effective working relationships with peers, supervisors and the public.

- j. Ability to learn the City's geography.
- k. Must possess, or be able to obtain by time of hire, a valid State Driver's License.
